Chief Ripley stated there has been a recent trend among Fire Departments to alter what is considered the passing time for the physical agility test to seven minutes. Discussion ensued on the reasoning behind the seven-minute time and ramifications moving forward.

Mr. Hawkins provided background information as to how the standard of 4 minutes and 30 seconds for the physical agility test certificate for firefighters came to be.

Chief Ripley stated his preference would be to maintain the current 4 minutes and 30 seconds benchmark and add the Auburn Career Center as an approved testing site, which the Commission accepted.

Chief Yakopovich provided reasoning as to why he would like certain names removed from the current consolidated Patrol Officer Eligibility list.

- Mr. Hawkins moved, second by Mr. Falkenstein, to remove candidates #5, #8, #9, #10 and #22 from the February 28, 2024 patrol officer consolidated eligibility list. The motion carried by a unanimous voice vote.
- Following review and calculation of results of examination, Mr. Falkenstein moved, second by Mr. Potkalitsky, to certify the results of the dispatch examination administered by April 22, 2024. Motion carried unanimously by a voice vote.
