3 4 Council members Jessica Brandt, Dave Finley, Jeff Garvas, Jan Tulley, and Vini J. **Present:** 5 Ventura. Also present: Law Director Mark Guidetti and Clerk of Council Jon Hoover. 6 7 INVOCATION & PLEDGE OF ALLEGIANCE 8 9 **APPROVAL OF MINUTES:** 10 Ms. Brandt moved, second by Mr. Garvas, to approve the minutes of the regular meeting of 11 September 12, 2024 as received from the Clerk of Council. The motion carried by a unanimous voice 12 13 vote. 14 15 **PUBLIC COMMENTS:** 16 17 ~ Chris Coblentz, 6770 Richard Rd., Boston Heights, spoke on the topic of RES.NO. 66-2024 and his wish for Council to approve the Valley Reserve PUD. The Mayor referenced a recent decision by the 18 19 BZA and questioned why Mr. Coblentz is asking for their not to be sidewalks on both sides of the roads within the planned development. Mr. Coblentz stated that several developments within the City do not 20 21 have sidewalks and with these being private drives thought sidewalks on one side of the road would be 22 acceptable. 23 24 Ms. Brandt asked clarifying questions on what the Planning Commission approves versus what Council approves, to which Mr. Coblentz stated the Planning Commission granted conditional approval of the 25 26 PUD, but that Council ultimately gives legislative approval. 27 28 Mr. Guidetti added that what Council is deciding tonight is whether to approve the conditional zoning certificate that the Planning Commission issued, along with the partial sidewalk waiver. Mr. Garvas 29 30 asked for clarification that a "yes" vote on RES.NO. 66-2024 would approve the waiver for sidewalks on both sides of the street, to which Mr. Guidetti confirmed. Mr. Guidetti further added that if RES.NO. 66-31 32 2024 were rejected, Mr. Coblentz would have the option to go back and work something out with the Planning Commission. 33 34 35 Mr. Coblentz added that he is trying to follow what has been done in the past with regards to sidewalks 36 within PUDs in the City. 37 38 **CORRESPONDENCE:** None 39 INTRODUCTION, READINGS & ADOPTION OF LEGISLATION 40 41 **RESOLUTION NO. 66-2024** 42 A RESOLUTION WAIVING THE REQUIREMENT FOR THE CONSTRUCTION OF FULL 43 44 SIDEWALKS AND OTHERWISE CONFIRMING THE CONDITIONAL ZONING CERTIFICATE AS APPROVED BY THE CITY OF MACEDONIA PLANNING COMMISSION IN REGARD TO THE 45 46 VALLEY RESERVE SUBDIVISION DEVELOPMENT PROJECT was offered by Mr. Finley for its 47 first, second and third readings by title only. Seconded by Ms. Brandt. The motion carried unanimously by a voice vote. 48 49 The Mayor referenced this legislation is what was discussed during the public comment period of the 50 meeting and asked Dir. Guidetti if Council could stipulate in approving the PUD that sidewalks be built 51 52 on both sides of the street, to which Dir. Guidetti replied Council can do that, but then the question

remains on whether the developer will build or not.

In response to a question from Mr. Garvas, Dir. Guidetti elaborated that Council can make amendments to 54 55 the legislative language as has been done in the past and leave at 1st reading to allow for more 56 consideration. The Mayor asked if there could be an administrative approval in consultation with Commissioner Monaco, to which Dir. Guidetti replied in the negative. 57

MAYOR'S REPORT

- ~Thanks to all who attended the amazing, safe FallFest last weekend
- ~The structure at 9150 Valley View will be demolished soon to make way for the new Service Department building and preparations have been made to have the process go as smoothly as possible
- ~Trick or Treating in Macedonia will be on October 31 from 6-8pm
- ~If residents have questions about the new trash contract, please go to the City website for FAQs, and if you have questions beyond that contact Dir. Wilson in the Service Department. Do not rely on random Facebook pages for correct information. The City does not negotiate a contract—by law the City must go out to bid and take the lowest and best. Every service that you have now will also be in place on December 1st. Ms. Tulley thanked the Mayor and Service Department for putting that information on the website as she has received several questions, including billing related, on the new contract. Ms. Tulley questioned why Republic did not automatically renew, to which Dir. Guidetti responded there was a set number of automatic renewals in the initial contract, and it was extended the maximum amount of time. The Mayor added that the City will have the option to do a similar automatic renewal if they are satisfied with the service. Ms. Brandt added there are two different discount options: one based solely on age that comes from the provider and one that is both age and income-based from the City.

COMMITTEE REPORTS

Parks & Recreation Commission: Ms. Brandt stated the Commission met on the 18th and had a discussion on future plans, including the new baseball field quad that is in the 5-year capital plan. The Commission remains excited about the paved trails throughout the park planned for 2025. The next meeting is October 16 at 6pm in the upstairs of the Rec Center

<u>Finance Committee</u>: Mr. Ventura stated that Finance Committee met this evening and discussed Family Rec Center and streets portion of the 2025 capital budget along with the debt going into next year. The Committee will meet again on October 24 to go over the 2025 operating budget, with Council having a 1st read of the budget.

<u>Cemetery Board</u>: Ms. Tulley reported the Board met last week and that a new garage door has been ordered. The flagpole donated to the Cemetery that was to be installed has been stolen. Work has begun on the budget and there is no anticipated request for an increase in funding from the communities.

DEPARTMENT REPORTS

<u>Service Department</u>: Director Wilson – Provided a more thorough detail and timeline of the trash contract process. Republic did make a mistake on their billing but will make it right—customers can choose to pay only two months of the bill or pay in full and be reimbursed. Trash/recycling services and dates with the new provider will remain the same.

Engineer: Director Gigliotti – Thanks to Council for passage of RES.NO. 67-2024. Road paving is wrapping up for the season, and a new road report that is done every three years will be forthcoming and presented to Council in the winter.

<u>Parks and Recreation Department</u>: – Director Chadock – Thanks to all departments for pitching in to help FallFest happen last week. The Haunted Manor at Longwood Park will be open for kids to come and get candy on October 19 from 4-6pm.

Finance Department: Director Veres – Thanks to Council for participating in the Finance Committee 159 160 meetings. At the October 26 meeting the 2025 operating budget will be discussed. 161 IT Department: Director Collins – 43 help desk tickets closed since the last Council meeting. Major 162 projects completed include the on-premises two factor authentication for the Police Department and 163 164 getting the new Clerk of Courts acclimated. 165 **Building Department:** Commissioner Monaco – Absent 166 167 168 **HR Department**: Director Smith – Absent 169 170 **Fire Department:** Chief Ripley – Fire Prevention Open House is October 9, which will have food trucks, the swearing-in of new employees, and activities for the kids. A \$50,000 grant was received for the 171 senior center meal program. The senior center will host a clambake on October 23. 172 173 174 **Police Department:** Chief Yakopovich – Thanks to Dir. Collins for keeping the Police Department LEADS compliant, and to Dir. Wilson and his staff for the renovation of the dispatch center. 175 176 Law Department: Director Guidetti – Provided additional detail and information on the trash contract 177 178 process. 179 180 **UNFINISHED BUSINESS**: None 181 182 NEW BUSINESS: Ms. Tulley thanked the Police Department for increased presence near Ledgeview 183 Elementary and Berkshire Drive. Ms. Tulley also thanked the Service Department for the work being 184 done at the corner of North Bedford and Ledge Road. 185 Ms. Brandt announced a public meeting will be held thirty minutes prior to the Council work session on 186 187 October 10 regarding the moratorium on recreational marijuana that will expire in December. Residents are welcome to attend and share their opinions on whether the City allows or does not allow the sale of 188 recreational marijuana. Information on the topic will be provided along with data from the State on what 189 190 is allowed and the rules that must be followed.
