RESOLUTION NO. 47 -2020**

**A RESOLUTION SUBMITTING THE QUESTION OF  
THE RENEWAL OF AN EXISTING 5.07 MILL TAX  
LEVY FOR THE PURPOSE OF CURRENT EXPENSES  
PURSUANT TO OHIO REVISED CODE SECTIONS  
5705.19(A) AND 5705.191, AND DECLARING AN  
EMERGENCY**

**WHEREAS**, the electors of this City on May 5, 2015 approved the renewal of a 5.07 mill tax levy for the purpose of current expenses; and

**WHEREAS**, the authority to levy the aforesaid tax expires with the levy heretofore made on the 2019 tax duplicate for distribution to the City in 2020; and

**WHEREAS**, this Council adopted Resolution 21-2020 on May 14, 2020, as amended on June 11, 2020 through the adoption of Resolution No. 39-2020, pursuant to Section 5705.03 of the Revised Code declaring it necessary to renew the aforesaid tax levy for a period of five years, and requesting the Summit County Fiscal Officer to certify the total current tax valuation of the City and the dollar amount of revenue that would be generated by that renewal levy; and

**WHEREAS**, the Summit County Fiscal Officer has certified that the total current tax valuation of the City is \$456,495,560.00 and the dollar amount of revenue that would be generated by that 5.07 mill renewal levy would be \$650,448.00 annually during the life of that levy, assuming that the total current tax valuation remains the same throughout the life of that levy; and

**WHEREAS**, this Council finds it necessary to proceed to renew the aforesaid tax levy in accordance with Revised Code Sections 5705.19(A) and 5705.191 in order to continue receiving such revenue without interruption;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Macedonia, Summit County, Ohio, not less than two-thirds of all the members thereof concurring, that:

**Section 1.** It is hereby found, determined and declared that the amount of taxes which may be raised by the City of Macedonia within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of the City, and that it is therefore necessary to levy a tax in excess of that limitation at a rate not exceeding 5.07 mill for the purpose of current expenses for a period of five years.

**Section 2.** The question of the renewal of the City's existing 5.07 mill tax levy for the purpose of current expenses for a period of five years, beginning with the tax list and duplicate for the year 2020, the proceeds of which levy first would be available to this City in the calendar year 2021, be submitted under the provisions of Ohio Revised Code Sections 5705.19(A) and 5705.191 to the electors of the City of Macedonia at the election to be held therein on November 3, 2020 as authorized by law. That election shall be held at the regular places of voting in this City as established by the Board of Elections of Summit County, Ohio, or otherwise, within the time provided by law and shall be conducted, canvassed and certified in the manner provided by law.

**Section 3.** The form of ballot to be cast at such election on the question of such tax shall be substantially as follows:

PROPOSED TAX LEVY (RENEWAL)  
CITY OF MACEDONIA

A majority affirmative vote is necessary for passage.

A renewal of a tax for the benefit of the City of Macedonia for the purpose of current expenses at a rate not exceeding 5.07 mills for each one dollar of valuation, which amounts to 50.7 cents for each one hundred dollars of valuation, for 5 years, commencing in 2020, first due in calendar year 2021.

**Section 4.** The Board of Elections of Summit County is hereby requested to cause notice of said election be given as provided by law.

**Section 5.** The Clerk of Council is hereby authorized and directed to forward a certified copy of this Resolution, Resolution No. 47 -2020, and the Summit County Fiscal Officer's certificate referred to in the preambles hereto, to the Board of Elections of Summit County on or before August 3, 2020.

**Section 6.** This Council finds and determines that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**Section 7.** This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, and for the further reason that this Resolution is required to be immediately effective in order to permit necessary arrangements to be made in sufficient time for the aforesaid election; wherefore, this Resolution shall be in full force and effect immediately upon its adoption and approval by the Mayor.
