It has come to my attention that the Macedonia City Council will be voting on a resolution opposing the steps Governor DeWine has taken during this pandemic. I also understand that your resolution is based on the principles outlined in the Great Barrington Declaration.

As a school media specialist, I teach my kids that the credibility of a works author or creator is the number one thing to look for. An author's credibility not only tells the reader how knowledgeable he or she is on the subject, but also if their views are accepted by their peers. Combining these two important pieces (along with currency, accuracy, relevancy and purpose), allows the reader to confidently know if the author has created new knowledge or unsubstantiated theories. Unsubstantiated theories have been taking over our society in recent years making it extremely important for the reader to assess the quality of the information they are receiving.

That said, I wonder if the Macedonia City Council has researched the authors of the Great Barrington Declaration other than seeing Oxford, Stanford and Harvard after their names. A search into their reputations and previous work raises several red flags as to the expertise they actually possess. A look into their declaration shows the World Health Organization and other widely accepted expert organization denounced the declaration stating "Relying on naturally obtaining herd immunity would be "scientifically and ethically problematic", Tedros said. "Allowing a dangerous virus that we don't fully understand to run free is simply unethical." (The Guardian). Another red flag raised was with some of the supposed experts who signed off on the declaration. There were "experts" who were unable to be located leaving the reporter to believe some names were fake.

When this many red flags occur in a source I tell my students to move on and find something more credible which will better support their theory.

While some on council may find the statements made in the Great Barrington Declaration support their personal beliefs, there is too much substantiated evidence showing that the steps Governor DeWine has implemented do indeed work. The wearing of masks, social distancing, curfews/avoiding crowds and the like have been proven to work. (CDC) So much so the folks who survived the last worldwide pandemic granted the governor the power to implement them. Hindsight is 20/20 and the people of Ohio who survived the Spanish Flu Pandemic of 1918 had the experience and knowledge to give the governor specific powers should Ohio face another pandemic in hopes of reducing casualties. Much is said about the character of those in local government who ignore the reasoning behind legislation.

Those Macedonia City Council members who follow through with this resolution, exhibit not only poor information literacy skills by not checking their sources, but also display a lack of character I believe is necessary to be a successful leader. I urge you to vote no on this resolution.

Dear Councilman Finley:

My husband and I were residents of the City of Macedonia for 14 years prior to moving to our current home in Walton Hills. We were not strangers to the City of Macedonia Council members nor various mayors throughout our tenure.

I stand up and applaud your resolution introduced in December 2020 (Res. 86-2020) opposing the Ohio Governor's executive orders. Thank you for drafting such a resolution and getting it on the record. As a former City of Macedonia resident, you have my support – 200%!! I feel that more elected officials need to stand up to the Ohio Executive Branch for the clear examples of overreach and excessive abuses of power by one branch of government. Of course, We the People must make this known to our elected officials as well.

One of the most egregious acts – of which there have been many – is the passage and signing into law Substitute House Bill 197 and, more recently, House Bill 404. Very important language in these two bills basically suspends the Ohio Sunshine Act where local citizens cannot attend in person public meetings with elected officials. The notion of 'virtual' meetings is not good enough in my opinion, and I have expressed this to my local council members in Walton Hills as well.

While residents of the City of Macedonia, my husband and I relied on local open public Council meetings to express our problems and frustrations with a stormwater issue that we had. We first moved to the City of Macedonia in June of 2005. In 2006, our basement filled with approximately eight feet of water on June 22. The summer of 2006 was when we first started approaching City Council and the Mayor's office for answers and for relief from our obvious stormwater problem. Our stormwater problems never went away and we knew that we needed to stay persistent for answers and for some sort of resolution. From January 2015 through December 2018, I attended every City Council meeting and spoke during the Public Comments portion of the meeting at least once a month. I wanted to address in person and on the record my elected Council members and Mayor with my own words spoken the way that I wanted to speak them. I wanted my elected Council members and elected Mayor to see me each month, whether speaking or not, as a visual reminder that I was still out there with the same old stormwater problem. I was not going to go away. I wanted to be visual and I wanted to be heard, and most importantly, I wanted answers.

It was two years ago on December 12 that we got the news that NEORSD was going to purchase our property through their Stormwater Management Program. We moved from the City of Macedonia in September 2019 and our home at 9186 North Bedford Road was demolished on July 28, 2020.

I am a firm believer that had our voices not been heard IN PERSON and had our faces not been seen IN PERSON we would have never gotten to this resolution. Others have issues that need to be addressed by local elected officials IN PERSON, and yet we all are being denied access to these public officials. It is shameful.

As a former resident of the City of Macedonia, I support your resolution; however, local municipalities everywhere need to open their meetings back up to the public once again. We the People must be seen and heard live and in person.

Thank you again for drafting this resolution.
